Opened: 30<sup>th</sup> November 2022

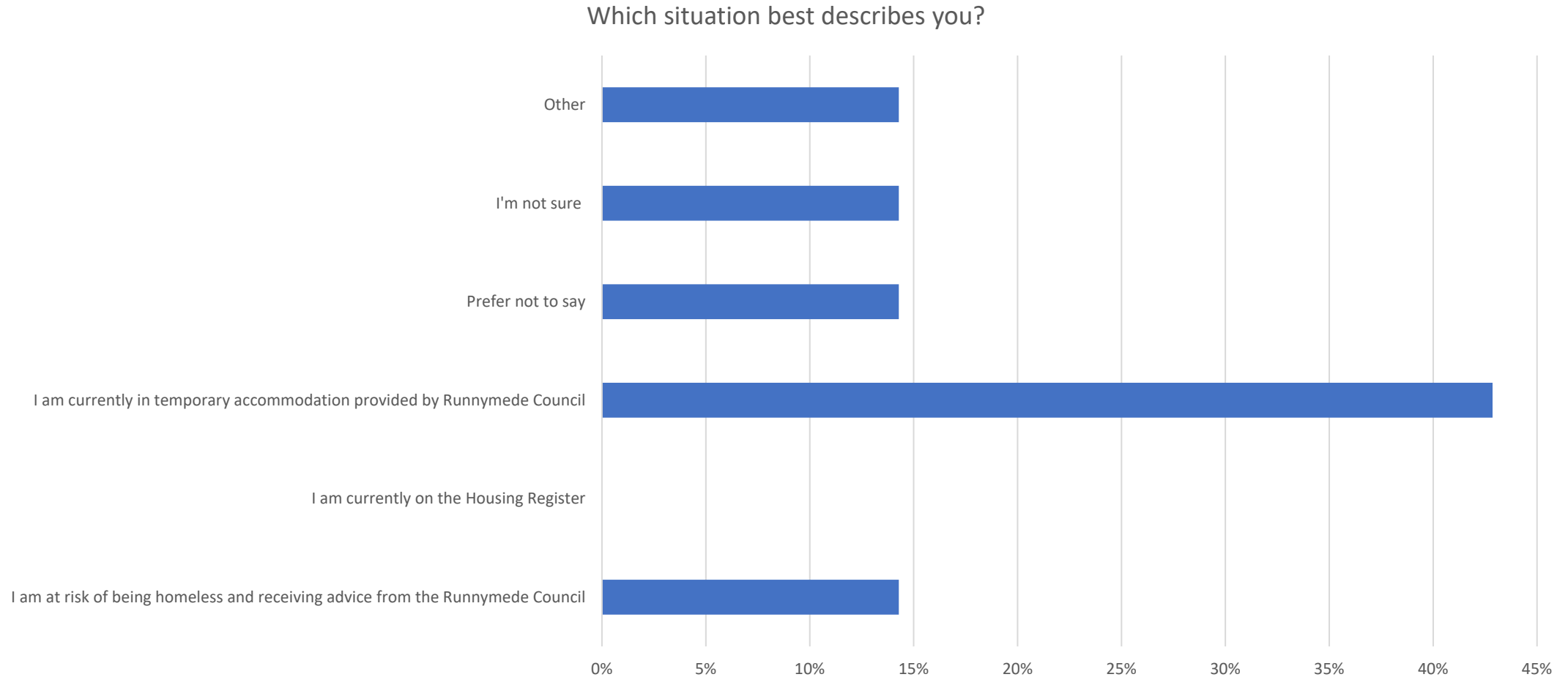
Closed: 25<sup>th</sup> January 2023

- Dedicated web page (191 page visits)
- All were sent a reminder email one week before closing, and the day before closing.

**Note:** Allocations team advised to only include: Open cases, Relief, and Prevention. The data was collated in November 2022.

# Q1: Which situation best describes you?

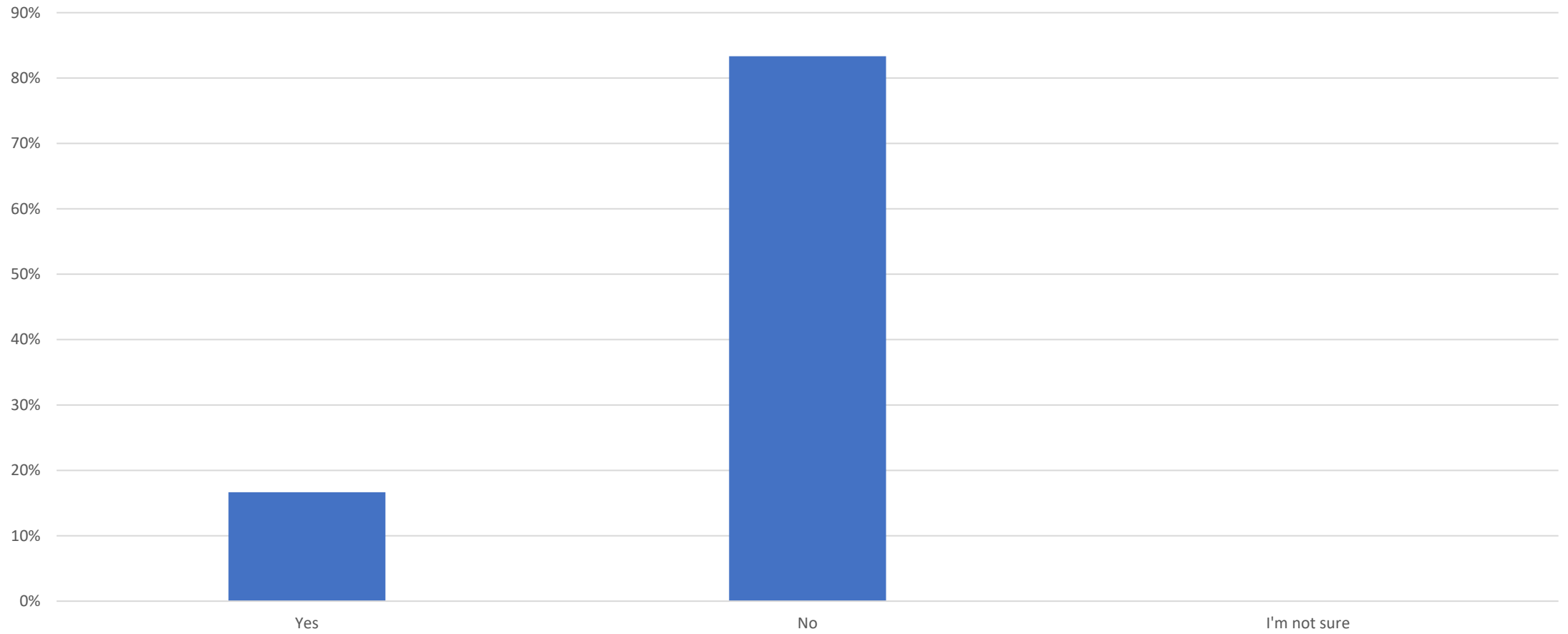

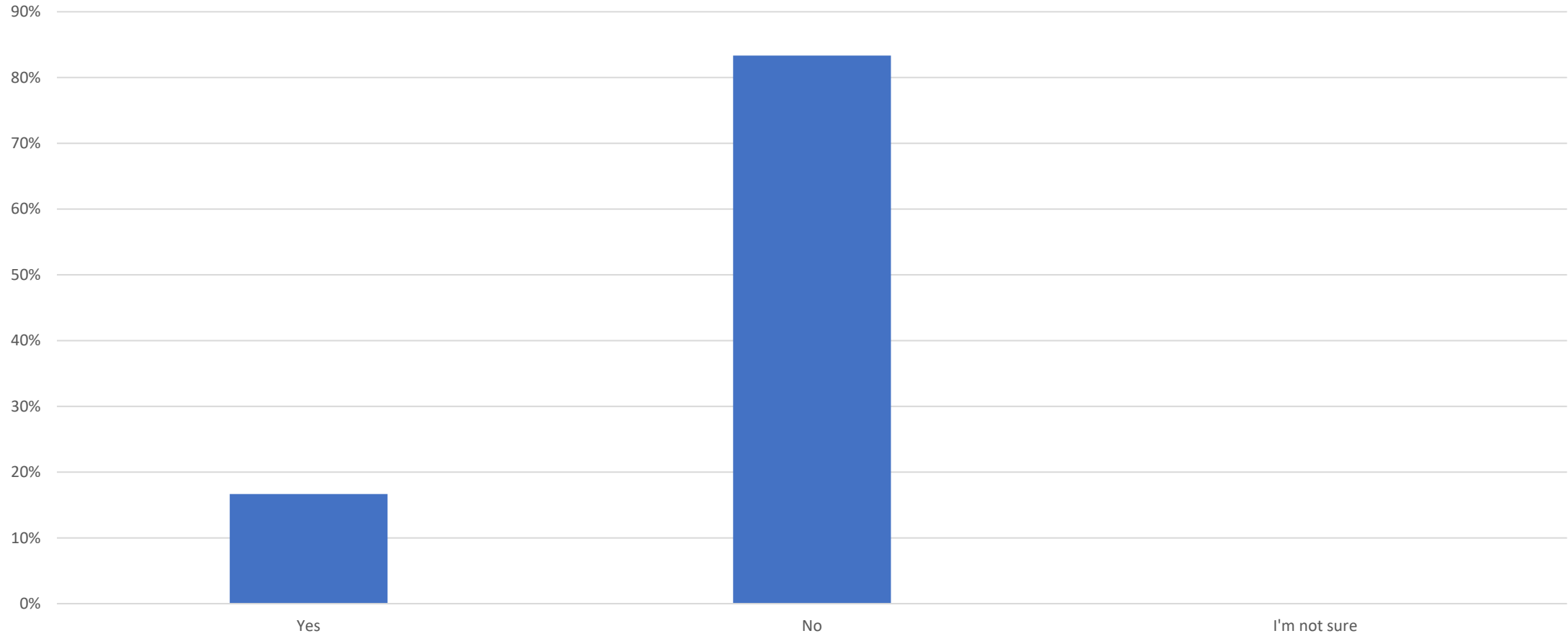

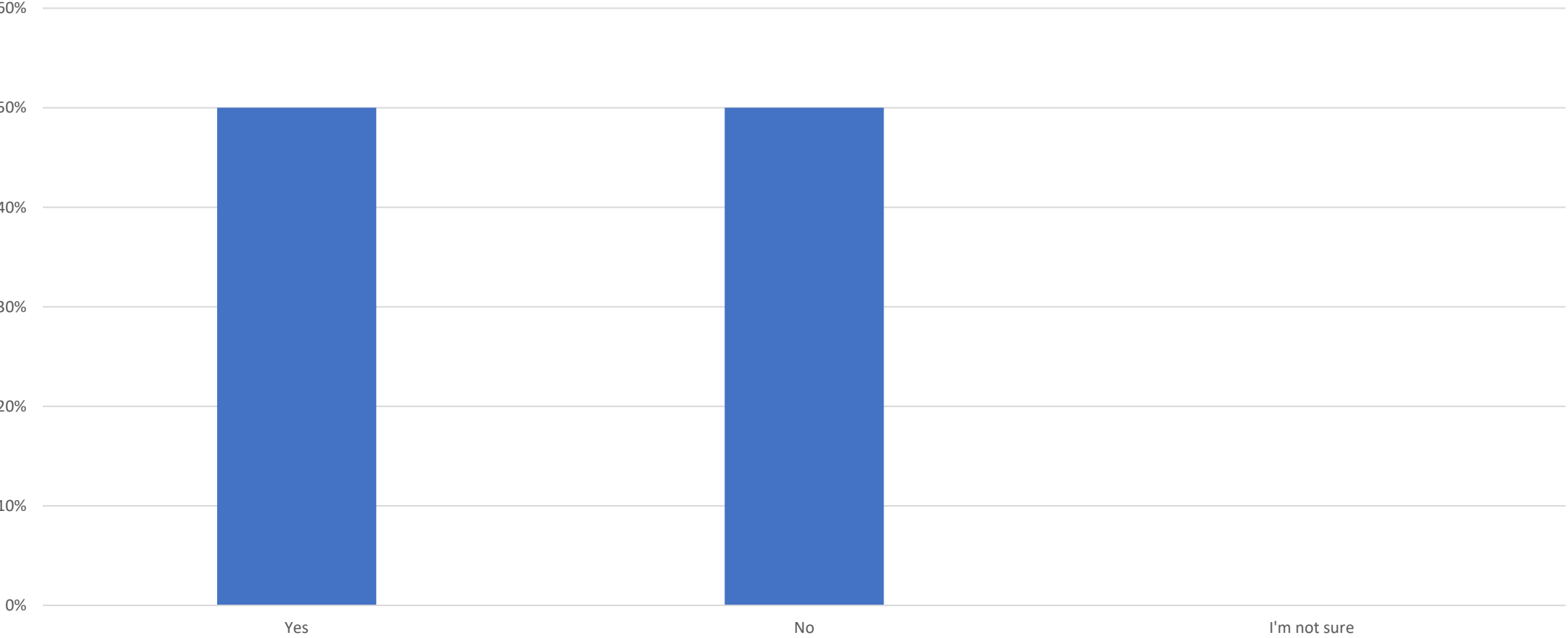

# Q6. Do you think we should consider suitable properties outside of Runnymede?

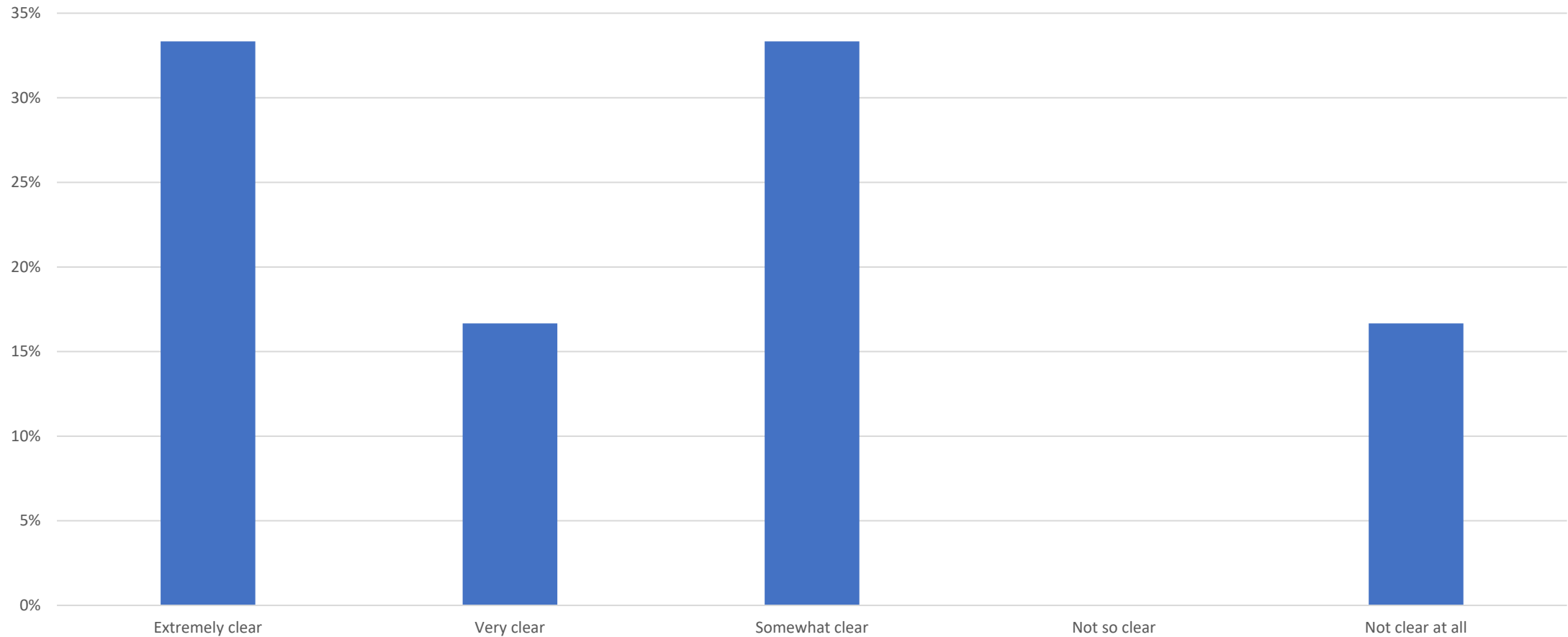


Do you think we should consider suitable properties outside of Runnymede?

How clearly do you feel this rule is communicated?

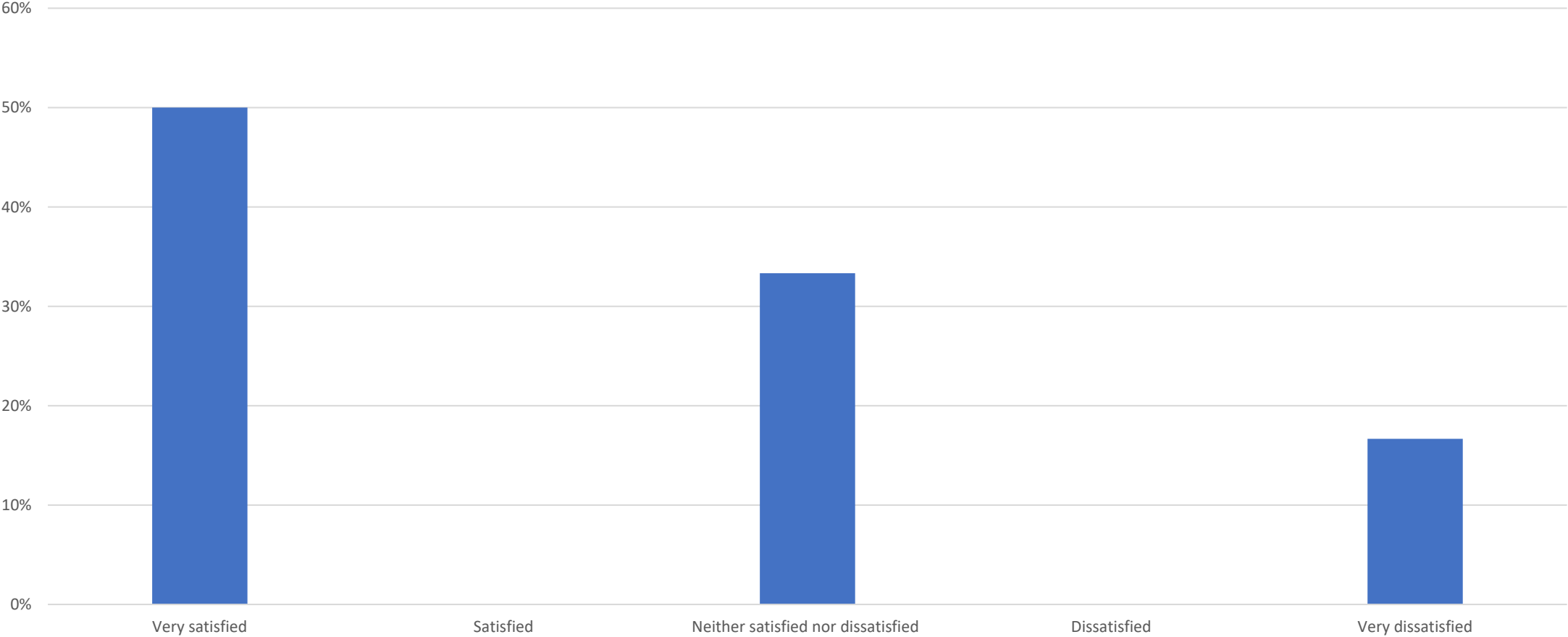
