#### Runnymede declares a Climate Emergency

Councillors in Runnymede have voted to declare a climate emergency in the borough. The declaration, which was approved at Full Council on 7th December 2023, allows the Council to officially recognise the global state of the climate and the need to reduce human impacts on it, whilst bringing greater attention to local action. This decision follows several years of work already carried out to reduce the Council's operational emissions in response to climate change. These efforts will continue in 2024 and beyond to pursue the net zero targets set in the Council's Climate Change Strategy.

## Have Your Say: Draft Climate Change Action Plan

Over the last six months, we have collected views across local communities, businesses, and residents to understand how we can work together to tackle climate change and improve our local environment. This feedback has been combined with relevant evidence from internal and external sources to create the Council's draft Climate Change Action Plan. The Action Plan includes around 70 actions to reduce both Council and borough-wide greenhouse gas emissions and adapt to the climate change that is already occurring, helping to deliver our Climate Change Strategy, and reach our net zero targets.

#### Have Yourself a Very Sustainable Christmas

However, the impact of our seasonal behaviour is substantial. According to Business Waste, the UK will throw away food equivalent to 42 million Christmas dishes, generate 125,000 tons of plastic, and throw away wrapping paper that, if laid flat, would wrap around the world nine times! This not only has a significant environmental impact, but is also bad for our pockets, with estimated spending across the UK of £700 million on unwanted gifts and £16 of £100 spent on food destined for the bin.

The positive news is that there are lots of resources available with hints and tips for having a more environmentally and financially sustainable Christmas while maintaining the joy of the festive period.
