Council adopts Runnymede Net Zero Carbon Toolkit

At Corporate Management Committee on 21 March 2024, the Council adopted the Runnymede Net Zero Carbon Toolkit. The Toolkit has been designed to assist building professionals and homeowners in the planning, design and construction of both new build and retrofit housing projects.

Pulling together the latest guidance and best practice, the Toolkit provides a useful technical, go-to guide on what to consider in the very early stages of design; how to achieve fabric efficiency; what systems to include; where to go for expert advice; and what to consider once you've finished your housing project.

Funded energy efficiency measures through ECO4 Flex



The ECO4 Scheme, provides funding for the installation of appropriate energy efficiency measures for low income households who are most likely to experience fuel poverty, and those who are vulnerable to the effects of a cold home.

Runnymede Borough Council's ECO 4 Flex Statement of Intent publicises the Council's participation in ECO 4 Flex and sets out the criteria that the Council will use to identify eligible consumers via Flex. This ensures transparency and public accountability in relation to the eligibility criteria.

Register for group-buying scheme Solar Together

Are you interested in installing solar panels on your property and generating your own electricity? Do you want to benefit from reduced install costs through a group buying scheme?

Solar Together is returning for another phase in Surrey with registrations for the scheme now open. It is free to register for the scheme and there is no obligation to go ahead with installations. For most homes, solar panels are classed as permitted development, so planning



permission is not required, although you should always check.

Have Your Say on the Energy SPD

The Council has published a draft Energy Supplementary Planning Document (SPD) for public consultation. The Energy SPD provides additional guidance to ensure the energy-related planning policies of the Runnymede 2030 Local Plan are applied to the best of their effect in tackling the climate emergency, and in bringing about new development which mitigates and adapts to the impacts of climate change.

Climate and sustainability funding available

We have been consistently updating our 'Climate Change and Sustainability Grants' page with available funding routes that support organisations and individuals to protect the environment. The Heathrow Community Trust Environment and Sustainability grants scheme, offering up to £15,000 per year, has recently re-opened, and there is still the opportunity to access support for your business to transition to electric vans if you regularly drive diesel vehicles on the A3 in Guildford.

RTS explains "downstream" measures

The River Thames Scheme (RTS) recently launched a 'Downstream Measures' campaign to explain how the flood alleviation scheme will provide a more effective route for floodwater to pass downstream. These downstream measures will work in tandem with the two new flood channel sections (in Runnymede and Spelthorne) to reduce flood risk for those who live or work in the scheme area.

For the RTS "downstream" refers to the area below the two flood channel sections. Proposals here include lowering the riverbed for around 1km between the downstream end of Desborough Cut and Walton Marina, and creating additional gates at Sunbury, Molesey and Teddington weirs.
