Could you be a Stop Idol?



We want to make an effective and lasting positive impact on Runnymede's air quality whilst helping to reduce local greenhouse gas emissions. To support this, we're encouraging drivers across Runnymede to 'Be a Stop Idol'.

As a Stop Idol, you can pledge to lead by example and turn off your vehicle's engine when stationary for more than 30 seconds. By doing this, you will avoid the negative, and entirely avoidable, consequences of idling, which include:

- Producing twice as much pollution compared to when turning the engine off,
- Adding to greenhouse gas emissions in the atmosphere, and
- Burning fuel while going nowhere, costing up to 3p per minute, or as much as £58 for 10 minutes per day over a six-month period.

Funded energy efficiency measures through ECO4 Flex



The ECO4 Scheme provides low income households, specifically homeowners or tenants, which are likely to experience fuel poverty and may suffer from the effects of having a cold home with funding to install energy efficiency measures.

Changes to the Council's pollution alert services

Air pollution levels within Runnymede are generally low, however very occasionally for around 20 days, pollution levels, normally in the summer months, are reached that may cause short term health problems for people with pre-existing respiratory problems.

If you are affected by air quality, for example through suffering from asthma, lung and cardiovascular disorders, you may want to sign up for the airTEXT service. This is a free text, call or email alert service for residents with respiratory problems to warn of increases in pollution levels capable of affecting health 24 hours in advance of elevated pollution events.

Are you eligible for a free home energy survey?

Zero Carbon Guildford offer free in-person energy advice and home energy surveys for eligible Surrey residents to reduce energy bills and cut emissions. The Home Energy Advice Taskforce (HEAT) provides these services through local Energy Champions who are able to offer free remedial measures where suitable, and signpost to other relevant information sources ensuring your property stays warm in winter and cool in summer. 

Delivering an EV chargepoint network across Surrey

Surrey County Council has formed a partnership with Connected Kerb to deliver an electric vehicle chargepoint network across Surrey by 2027. The scheme will give Surrey residents, especially those without off-street parking, the confidence to move to an electric vehicle and charging at locations that work best for residents. Connected Kerb will install a mix of chargepoints, depending on location, to suit all needs, from rapid chargers in areas of high demand, to slower lamp post chargepoints where alternatives are not feasible. The partnership wants to work closely with residents and community landowners to identify opportunities on community land where chargepoints could be installed. This includes public and not-for-profit organisations, such as schools, community groups, churches, and more, where Connected Kerb would fully fund the infrastructure if there is 24/7 car park access in a suitable location, with the organisation qualifying for a share of the charging revenue once installed.

The proposed chargepoint locations are available to see online, and any feedback or questions about these proposals is being welcomed. Additionally, you can request for a chargepoint location to be added if there is not currently one proposed in your area, and public and not-for-profit organisations can register their interest in the scheme.



Walking trails help share RTS vision

The River Thames Scheme (RTS) has launched two walking trails near the Desborough Cut, between Weybridge and Walton-on-Thames. The Desborough Island Loop and the Broad Water Loop offer exciting opportunities for local people and visitors alike to explore the outdoors, observe local wildlife and learn about the varied history of the area.

More than just scenic walks, these trails are designed to educate visitors about the initiatives the RTS will be implementing in the area, such as habitat creation and new areas for wildlife conservation
